PROUD MEADOWS BREEDING AGREEMENT

TERM:

This agreement will expire no later than 3 years from the date of the first shipment of semen, or sooner if the contracted mare produces a live foal. A live foal is defined as one who stands and nurses after delivery.

TRANSFER:

Subject to the approval of Proud Meadows, the Mare owner may transfer this Breeding Agreement to another Mare if for some reason the contracted Mare is unable to conceive. Proud Meadows requires a \$250.00 Transfer Fee and a written document from the inseminating veterinarian that the original Mare was not able to conceive and that it is recommended the Mare should not be rebred. The original termination date of this agreement will apply to transfers. This Agreement is not transferable to any other Mare Owner without proper documentation in place, the approval of Proud Meadows and a \$250.00 Mare Owner Transfer Fee.

GENERAL PROVISIONS:

1. Mare will be artificially inseminated.
2. Semen will only be sent to Mare owner's veterinarian. Exceptions to this provision must be documented.
3. Mare owner's veterinarian must certify that only the Mare named above was inseminated and that all unused semen was destroyed.
4. The total breeding fee or the additional collection fee must be paid prior to the shipment of semen.
5. The Mare owner is responsible to return the semen shipment container to Proud Meadows within five (5) days after the shipment is received. If the container is not returned, the Mare owner agrees to pay Proud Meadows \$250.00.
6. All fees may be charged to Visa or MasterCard.
7. ***Owners of Pure Bred Friesian Mares must submit a copy of the Mare's registration papers with the Breeding Agreement.***

AVAILABILITY:

1. Proud Meadows will make every attempt to ensure prompt delivery of semen at the Mare owner's request. Due to performance schedules of the Stallions, there will be blackout periods for individual Stallions; please check with Proud Meadows for blackout periods.
2. ***Proud Meadows collects Monday through Friday, except holidays. The Stallions are collected before 10:00 a.m. Central Standard Time. If a request comes in later, the Stallion requested will not be collected until the following day.***
3. Our standard shipping provision is UPS or FedEx, overnight A.M. delivery. ***It is the responsibility of the Mare owner to ensure UPS and/or FedEx delivers to the address requested, especially for Saturday deliveries.*** If other shipping arrangements are requested, all arrangements will be made and expense paid for by the Mare owner. ***There will be no refunds for shipments that do not arrive timely through no fault of Proud Meadows.***
4. Due to the heat in Texas and health considerations of the Stallions, we usually do not collect the stallions in the month of August. If special arrangements are necessary, your request must be submitted prior to 5:00 p.m. the day before shipment, Monday through Friday only.

FROZEN SEMEN:

Proud Meadows has Frozen Semen available for Jorrit and Tinus. If you are considering frozen semen, call Proud Meadows well in advance of requested delivery date for details and protocol.
